# **GUIDELINES AND ASSUMPTIONS**

- 1. There will be a capital campaign in 2024. It will kick off in the latter part of 4th quarter 2023, or 1st quarter 2024 at the latest. There will be a need to spend operating budget dollars to cover the cost of the capital campaign consultant. A separate capital campaign budget will be developed.
- 2. There will be staff pay increases comparable to market increases. Staff realignments will be considered.
- 3. An effort will be made to diversify the income base for community engagement and social services. A separate 501(c)(3) will be set up to attain this goal.
- 4. An effort will be made to leverage other assets—for example real estate, modular buildings—to diversify income stream of the church.
- 5. Our staff will continue to be offsite in office facilities for 2024.
- 6. A capital expenditures budget will be developed in consultation with the Board of Trustees and the project manager, Pastor Carl Lavallais.
- 7. Modular buildings will be used for ministry meeting spaces.
- 8. The goal is a flat (or reduced), balanced budget not to exceed \$3 million.

- 3. Total Expenses: Enter the **total** amount that will be **spent** each month at the **bottom** *and* **far right**.
